GRANT HISTORY

You will recall the note in the Treasurer's Report that since 1997, the MHCG has been successful in securing grants to the total of \$270,747 and we thought you'd be interested to see where the funds have come from. On two occasions (1,2) the funds were awarded in MHCG name but expended on our behalf by Parks Victoria. Once (3 - Port Phillip Bay Fund) MHCG agreed to apply for and administer funding for a full-scale project co-ordinated by Naturelinks, extending through the areas worked by Friends of Chinamans Creek, Friends of Rosebud Beach & Foreshore and up to the most easterly point of McCrae Beach. And lastly MHCG made a submission to the 2020 Shire Budget for funding to commence remedial works in and around Eyrie Creek. The success of Len Evans & Barry Robinson in the beginning, and now Margaret Wilson & Jenny Warfe carrying on the tradition, can be seen everywhere you now look around all the locations which are healthy and thriving, providing important habitat for local fauna and wonderful amenity to our local foreshore which is enjoyed by thousands of people every year.
